Freelance work via Ross Russell Limited: April 2005 to date

I am working as a professional pension trustee and I am the sole director and only active trustee within the firm. My trusteeship work involves chairing several trustee boards, participating as professional trustee in several others and acting as investment committee member for one more, involving schemes with total membership of over 100,000 and assets of over £10 billion. I am also involved periodically (but not currently) in actuarial consulting work and expert witness work involving actuarial disputes.

In the last few years substantially all of my work has been as a professional trustee. Key issues dealt with recently include:

- Negotiation of statements of funding principles under the scheme specific funding regime (usually via chairing a Funding Sub-Committee);
- Negotiation of liability management exercises including pension increase exchange and transfer options;
- Negotiating security packages including Asset Backed Contributions, direct security over shares and assets of subsidiary companies and bank guarantees / letters of credit;
- Covenant assessment for participating employers;
- Assessment of section 75 debts on the exit of participating companies;
- Preparing and updating risk control strategies including market-driven and funding level-driven automatic derisking strategies, buy-ins and buy-outs and longevity hedging;
- Participating in or chairing investment sub-committees dealing with (for different schemes) Liability
 Driven Investment ("LDI") strategies, active currency management, private equity investments,
 infrastructure investments, and investment strategy more generally;
- Appointment and reappointment of advisers;
- Litigation and settlement discussions.

Milestones and Achievements

- In 2015, I oversaw the negotiation of a £1bn security package and £800m Asset Backed Contributions to finance and secure a material DB scheme deficit.
- In the run-up to 2018, I took one £900m scheme progressively through a derisking plan (including a liability management programme); an annuity buy-in of pensioner liabilities; an annuity buy-in of non-pensioners liabilities and an eventual wind-up securing all member benefits in full.
- In 2013, I led the group that secured a successful outcome to funding negotiations for a distressed £4 billion scheme involving intensive "early engagement" by the pensions regulator and an eventual £750m special contribution.
- In the run-up to 2012, I oversaw the merger of activities for two schemes of the same employer, including common adviser appointments and investment arrangements and eventually a merger of schemes, with significant cost savings.

Hymans Robertson Consultants and Actuaries: January 1987 to April 2005 (18 years)

Hymans Robertson is an independent firm of actuaries, investment and pension consultants with (at the time I left the firm) 25 partners, 320 staff and annual revenues of some £25 million. The firm is a leading provider of services to private sector occupation pension schemes and to local government schemes. I joined as a nearly qualified actuary in 1986 and progressed to equity partner level in 1991. I was the senior partner in the London office of the firm and one of two partners with top tier equity participation.

I held various positions within the firm, primarily as part of the actuarial team but also including management roles within the broader firm. These roles have included the following.

- Practice leader of the firm's actuarial practice: April 2000 to April 2005. The actuarial practice
 was then a 100 strong team of professionals with revenues of some £12 million and with a market
 leading position in public-sector and private sector pensions consulting. The firm then operated
 from offices in London, Glasgow and Birmingham. I was responsible for a team of some 30
 actuaries, 60 back-up staff plus the actuarial systems development and research teams. During this
 period the firm more than trebled revenues and my team consistently outperformed its demanding
 profitability targets.
- Head of the firm's London office: 1995 to 2000. Prior to 2000 the firm's management operated
 on a geographical basis (as opposed to the later practice area reporting structure). The role involved
 responsibility for all aspects of the firm's work including third party administration services, actuarial
 and consulting services and risk benefits. I participated throughout in the firm's four-strong
 management committee.
- Finance partner: 1993 to 1997. I oversaw the development of the firm's finance and accounting function. This included the implementation of a new financial management system.
- Research Partner: 1991 to 1993. I was responsible for all published research for the employee benefits part of the firm.
- Professional actuarial adviser: 1989 to 2005. Throughout my period with the firm my primary
 role was as a professional adviser to UK pension schemes, both as scheme actuary and in a broader
 consulting role. I had personal scheme actuary appointments for a dozen major schemes including
 two with more than £1 billion of assets. I successfully won business via competitive tenders and I
 have managed these to a high degree of profitability and client service. I was also involved in high
 profile expert witness and dispute resolution work.

In addition to the above functions within Hymans Robertson, my project work for the firm included the following:

- Overseeing the successful de-merger of the firm's Insurance Consulting in 2002.
- Developing and launching the firm's practice-based management structure in 2000.

Reason for leaving:

I gave notice of retirement from Hymans Robertson in April 2004 and this only took effect from April 2005. My primary project was to design and build a house for me and my wife in Suffolk and I planned to undertake freelance work including trusteeships.
